# Land Registers Interconnection

**LRI aims to provide a single access point within the European e-Justice Portal to the land registers of participating EU countries. This will address the current issues of discrepancy, complexity and multitude of land registration systems amongst Member States. Through this access point citizens and professionals will be able to query and retrieve relevant information via a single, adaptive, multi-lingual interface, in compliance with the national legal and technical capabilities.**
